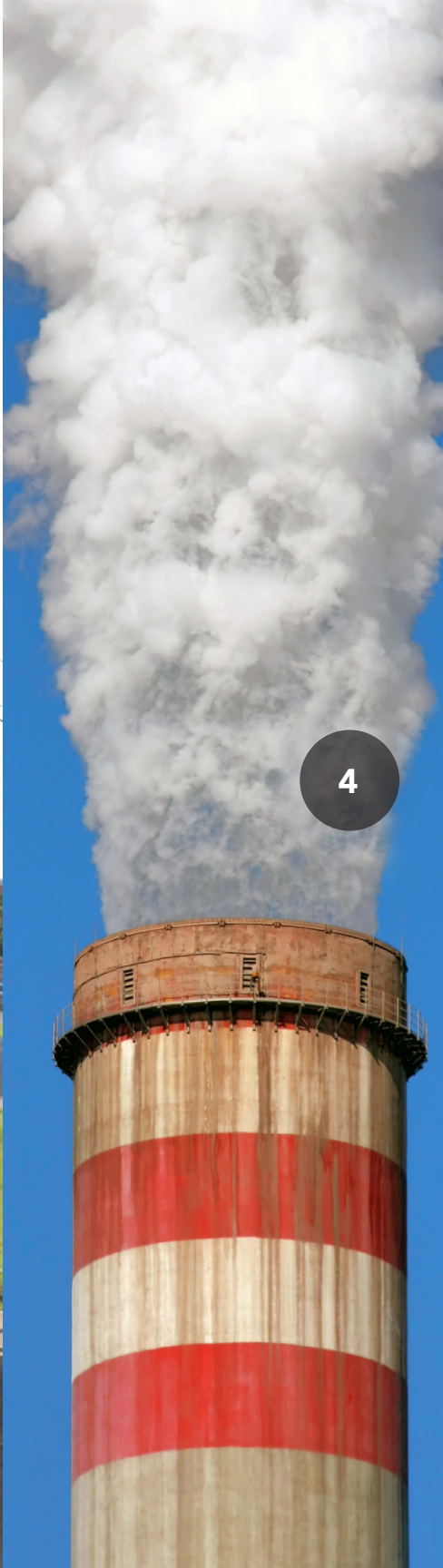

DRUG AND ALCOHOL TESTING

DOT rules state that any motor carrier, interstate or intrastate, operating a vehicle over 26,001 pounds, or transporting 16 or more passengers including the driver, or any vehicle transporting hazardous materials, must participate in a compliant Drug and Alcohol testing program, regardless of size. That also applies to owner operators.

This program must include pre-employment, random and post accident testing.
